2.4 The Company may circulate news and articles related to the industry and may provide specific regulatory updates from time to time; and

2.5 The Company may conduct an introductory familiarization program / presentation, when a new Independent Director comes on the Board of the Company.

3. Disclosure of the Policy

This Policy shall be uploaded on the Company's website for public information and same shall also be provided in the Annual Report of the Company.

The Board will review this Program and make revisions as may be required.
